First of all, we assure you that the processing of your personal data takes place in accordance with the principles set out in both Polish and EU legal order, i.e. in accordance with the Personal Data Protection Act of 25 May 2018 (with as amended) and the regulations of the General Data Protection Regulation Personal Data Protection (RODO).

PRIVACY POLICY

This Privacy Policy explains the principles under which personal data are processed, provided in the course of your cooperation with our company and when using our website. This document explains what rights accompany you in relation to our processing of your data.

I. Personal data controller

II. Source and method of processing of personal data

We hold the personal data processed directly from you. You provide it to us, by visiting our website and by filling in an enquiry or order form.

Your data is:

- a. processed transparently for the purpose of processing your order and/or enquiry;
- b. up-to-date and accurate - if you notice that your data is incorrect or incomplete, please contact us here. We will correct it, or withhold further processing;
- c. correct, adequate and not excessive in quantity;
- d. secure;
- e. kept no longer than necessary.

III. On what basis and why do we process your personal data?

We process your personal data:

- a. in order to process your order and/or request;
- b. because of our legitimate interest;
- c. because you have given your consent by ticking the relevant checkbox. However, remember, consent is voluntary and you can withdraw it at any time, without affecting the lawfulness of the lawfulness of the processing that was carried out on the basis of that consent before revocation. - d. due to a legal obligation incumbent upon us.

The data are processed taking into account the principles of: accountability, adequacy and reliability.

IV. Is the provision of data mandatory?

The provision of your data is mandatory insofar as it enables us to fulfil the contract for the provision of services. In addition, there are situations where the law compels us to require you to provide

you to provide specific data, or to give the relevant consent (e.g. in the case of special special categories of data).

In all other cases, your provision of data is voluntary.

V. With whom is the data shared?

Your data may be shared with entities with whom we cooperate (hosting provider; IT). At the same time, we assure you that we only cooperate with entities that take special care to protect your personal data. Based on applicable law, we may be obliged to disclose your personal data to personal data to public authorities due to possible investigations.

Your data is not used for decision-making based on automated data processing. If the recipient of your personal data is located in a country outside the EU/EEA country which does not ensure an adequate level of data protection, your personal data will only be transferred to such a recipient after you have entered into a written agreement with them for the

transfer based on the standard contractual clauses adopted by the European Commission.

VI. Objection and other rights.

You have the right to object to our processing of your personal data.

In addition, you have the right to request rectification, erasure and restriction of data processing, as well as data portability.

VII. How long is the data stored?

Data is stored for the duration of the services provided and for the period resulting from the period of limitation of claims, consumer rights, bookkeeping or other rights in this respect.
